

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, 18 YEARS OF AGE OR OVER. INTERNET ACCESS REQUIRED.

- Promotion Period:** Welch's® Fruit Snacks LEGOLAND Sweepstakes (the "**Promotion**") begins March 3, 2020 at 12:00 a.m. Eastern Time ("**ET**") and ends May 31, 2020 at 11:59 p.m. ET (the "**Promotion Period**").

Sponsor reserves the right to cancel, terminate or modify the Promotion if it cannot be completed as planned for any reason, including infection by

computer virus, bugs, tampering, unauthorized intervention, technical failures or corruption of any sort. In such event, Sponsor will award Grand Prize in a random drawing from among all eligible Entries received prior to cancellation.
